MEDIA RELEASE - ASX-Listed Holista in Joint Venture With Indian Herbal Expert Hi-Tech Biosciences

Malaysian-based, Australian-listed Holista teams up with India's Hi-Tech Biosciences To Develop and Commercialise Herbal Medicine

Kuala Lumpur/Perth, 7 July 2011 – Australian Securities Exchange-listed (ASX :HCT) **Holista CollTech Limited** ("Holista"), a biotech research company with operations in Australia and Malaysia, announced today that it has formed a joint-venture with Hi-Tech Biosciences of India ("HTB"), to develop, patent and commercialise herbs for medical applications worldwide.

Pune-based HTB, a herbal extractor that has categorized 138 major Indian herbs and owns a proprietary fuel-efficient extraction process, will hold a 60% stake in the joint venture - Equinox Herbals Limited ("Equinox") - with Holista holding the balance. Profits from the venture headquartered in Pune, India, will be shared equally.

While Indian herbs have been in use for thousands of years in traditional Ayurvedic or Siddhi medicine, its acceptance in the international marketplace has been hindered by lack of formal patents, distribution channels and formal acceptance by health authorities.

The joint-venture will leverage on HTB's ongoing research and development, categorization and manufacturing. Holista will transfer extraction equipment it currently owns as contribution to the joint venture, and will be responsible for global sales and marketing.

Mr. Raghavendra Gaikaiwari, MD of Hi-Tech Biosciences of India, said the joint-venture will allow HTB to focus on research and development and manufacturing and tap on Holista's marketing expertise. "We have known each other for more than 10 years, so this joint venture is a natural evolution of our relationship. It is time for India and Indian companies to go global with our herbal heritage," he said.

Dr. Rajendran Marnickavasagar, CEO of Holista CollTech Limited, said access to HTB's herbal extraction expertise will provide an edge in cost and quality compliance. "We are also looking at extraction and micro extraction of Malaysian herbs. Partnership with HTB will

provide us world-class expertise while maintaining a cost advantage. We will also be filing

some unique new patents in collaboration with the Indian Institute of Integrative Medicine

and the U.S.-based National Center for Natural Products Research", he said.

Holista has filed three patents for Malaysian herbs and expects to file two more soon.

For a start, Equinox will work on three of India's leading herbs:

Ashwaganda (Withania somnifera) which is commonly known as Indian Ginseng,

and having rejuvenation and anti-aging effects

Amla (Emblica officinalis) which is commonly known as the Indian Gooseberry, is

one of nature's richest sources of Vitamin C

Boswelia (Boswellia serrata) which is used in treating diseases affecting joints and is

currently India's most exported herb

Holista has received expressions of interest from one of China's largest multi-level marketing

companies to market these three herbal extracts.

Separately, Equinox Herbals is also working on extraction of Kacip Fatima (Labisia pumila) -

a Malaysian herb which has been used as a traditional female tonic.

The Indian High Commissioner to Malaysia, His Excellency Mr. Vijay K. Gokhale,

welcomed the joint-venture. "It is truly nice to see an Indo-Australian joint venture birthed

here in Malaysia. Indeed, Indian herbs have great potential. India is also pleased to help

Malaysia develop the riches of her own rainforest," he said.
